

COMPARATIVE SECTION TABLE

Editor's note--The 1985 Codified Ordinances of Jackson County comprises orders, ordinances or resolutions enacted by the Board of County Commissioners or new matter ordained by the Adopting Ordinance. Sections and subsections of the 1985 Codified Ordinances without a history or with the words "Adopting Ordinance" at the end thereof are or contain new matter which was approved, adopted and enacted by the ordinance that approved, adopted and enacted these Codified Ordinances (the "Adopting Ordinance"), i.e. the section or subsection did not exist in any form before it was ordained by the Adopting Ordinance or it existed but was substantively modified by the editors, pursuant to instruction from County Counsel, to conform to current State law and local practice and to eliminate errors, ambiguities, inconsistencies and other irregularities. In the following table the disposition of all source material in the 1985 Jackson County Codified Ordinances is indicated.
